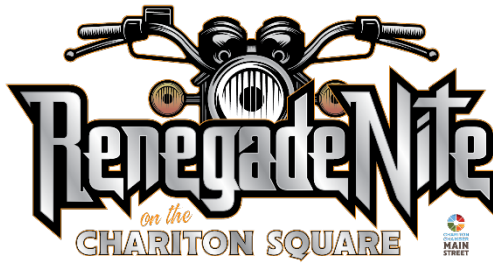

VENDOR AGREEMENT

This agreement (herein "Agreement") is entered into this _____ day of _____, 2023, between applicant (herein "Vendor") and Renegade Nite on the Chariton Square Committee and Chariton Area Chamber/Main Street LLC, whose address is P.O. Box 735, Chariton, IA 50049.

Term: Renegade Nite on the Chariton Square agrees to provide Vendor a space on the Chariton Square to use as a display/vending area (herein "License") during Renegade Nite on the Chariton Square scheduled for ___ Friday, June 2nd, 2023 from 5pm-10pm, ___ Friday, July 7th, 2023 from 5pm-10pm, ___ Friday, August 4th, 2023 from 5pm-10pm. Vendor may start to set-up space any time after 2pm and must be vacated 11pm.

Price: \$50.00 or \$75.00 **per event** (depending on booth size) via money order or check to be received three (3) weeks before the event, along with, this signed agreement. This should be mailed to P.O. Box 735, Chariton, IA 50049. Checks made payable to: Chariton Area Chamber/Main Street, LLC.

Additional Terms: Vendor must have approved city and state licenses. Vendor must have necessary utilities to operate. Vendor may sell beverages but may not sell alcoholic beverages.

Free Market Economy: Vendor acknowledges that there are no promises of exclusivity of product. Other vendors may be selling same or similar items.

Rainout: In the case of a rainout, the event will be canceled, and any vendor fees will be carried over to the next event date or year.

Indemnification: Vendor hereby agrees to indemnify, defend and hold harmless: Chariton Area Chamber/Main Street, LLC, Renegade Nite on the Chariton Square Organization, Committee, Board of Directors, City of Chariton, County of Lucas Iowa, employees, volunteers and agents, from and against any and all liability and expense in connection with any claim by a third party arising out of Vendor conduct or out this Agreement including, but not limited to: any claims for breach of trademark, copyright or related intellectual property rights, sickness, incident or accident caused by Vendor. Vendor shall maintain a comprehensive general liability insurance policy.

Breach: Upon breach of the Agreement by Vendor, Renegade Nite on the Chariton Square shall be entitled to terminate this Agreement for cause and retain all sums paid pursuant to paragraph three above.
