# COSTUME/GARMENT RENTAL POLICIES

## DEPOSITS:

All rentals require a security deposit. Deposits vary by item and cost \$25-\$50. The security deposit will be charged with the rental fee and will be refunded when the rental is complete (if all items are returned in the same condition as rented out, as described in more detail below).

## ALTERATIONS:

If costumes/garments are temporarily adjusted to fit, **they must be returned in their original condition**. If a costume/garment is returned altered or damaged, the security deposit may not be refunded. Costumes/garments may NOT be cut, dyed, painted, or embellished. Tape, iron-on bonding web, glue, or any other type of adhesives may not be used on garments/costumes.

## DAMAGED OR LOST COSTUMES/GARMENTS:

Normal wear and tear on costumes/garments is expected. Damage beyond normal wear and tear may result in the forfeiture of the security deposit. Damage is considered tearing, burning, cutting, staining, broken zippers, removal of garment pieces, or other damage that renders the costume unrentable. The deposit covers the cost to restore the garment to a rentable state. Costumes/garments will be assessed for damage upon return. Lost costumes result in the forfeiture of the security deposit.

## DISCLAIMER:

The Renter agrees to use the costumes or other items rented at Renter's own risk and will indemnify and hold CACMS harmless from any personal injury or property damages resulting from the Renter's use or misuse of the items rented.
